RIDE CONNECTION'S SERVICES MEET THE TRANSPORTATION NEEDS OF EACH INDIVIDUAL BY OFFERING A VARIETY OF TRANSPORTATION OPTIONS. OUR PROGRAMS ARE DESIGNED FOR OLDER ADULTS, PEOPLE WITH DISABILITIES, VETERANS, LOW INCOME INDIVIDUALS AND THE GENERAL PUBLIC. FROM PUBLIC TRANSIT TRAINING TO GROCERY SHOPPING SHUTTLES AND TO MEDICAL APPOINTMENTS, OUR PRIORITY IS TO ENSURE EVERY PERSON HAS ACCESS TO RELIABLE AND ACCESSIBLE TRANSPORTATION. THIS LAST FISCAL YEAR, RIDE CONNECTION PROVIDED NEARLY 547,000 DOOR-TO-DOOR RIDES, TRAINED 333 PEOPLE TO USE PUBLIC TRANSIT, AND INTRODUCED OVER 1,824 PEOPLE TO PUBLIC TRANSPORTATION OPTIONS. THESE NUMBERS ARE NOT INDICATIVE OF THE MYRIAD POSITIVE EFFECTS OF GAINING ACCESS TO TRANSPORTATION WHICH ARE PERSONALLY SIGNIFICANT, LONG-LASTING, AND GLOBALLY BENEFICIAL.
