Every phone call, travel training session, ride and customer interaction has a significant impact on those we serve and it is an honor to lead this organization.

We hear daily that the services we provide are a lifeline. Ride Connection is there for the person who needs more than 35 seconds to cross 4 lanes of traffic at a stop light, for the person who needs to roll or walk an extra 2-4 blocks in order to find a curb cut where they can exit the sidewalk safely, and for the person who just spent 4 hours receiving dialysis who desperately wants to get home, warm up and have a rest.

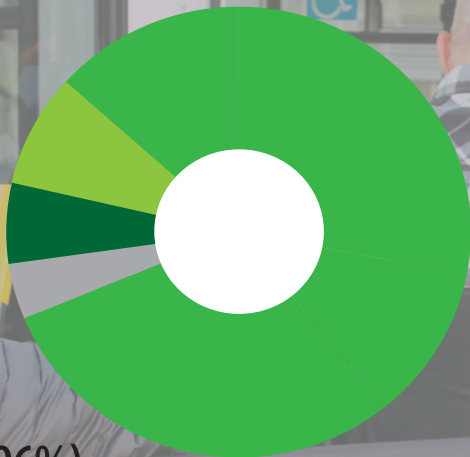

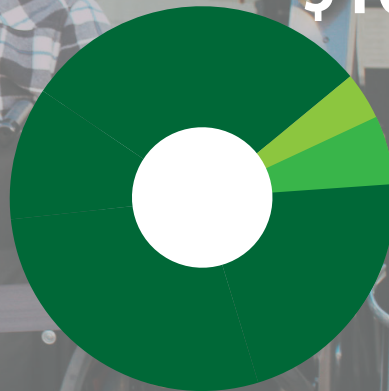
