EXPLANATION OF RIGHTS OF OREGON RESIDENTS TO OPT-OUT OF PROCESSING YOUR PERSONAL DATA FOR TARGETED ADVERTISING OR PROFILING OR TO OPT-OUT OF THE SALE OF YOUR PERSONAL DATA:

If you are an Oregon resident (“**you**” or “**your**” or “**Oregon Resident**”), you may have the right to opt-out of the processing of your Personal Data for targeted advertising or profiling and/or opt-out of the sale of your Personal Data under the Oregon Consumer Privacy Act (the “**Oregon OCPA**”

WAYS WE MAY “SELL” OR “SHARE” PERSONAL INFORMATION

RIDE CONNECTION, INC., an Oregon nonprofit corporation, (“**Company**” or “**we**” or “**us**” or “**our**”) may be deemed to “sell” or “share” the Personal Information of an Oregon Resident under the Oregon OCPA, as a result of one or more of the following activities:

- Personal information may be shared, disclosed or distributed for any one or more of the following purposes between and/or amongst us and/or one or more of our Our transportation partners or other entities that we work with or partner with in order to provide You with transportation services or with any other Services, as such term is defined in our Privacy Policy (hereinafter collectively defined and referred to as “**Business Partners**”) for the following activities:
 - (i) To allow us to provide you with the transportation services or other Services you have requested by or through us or any of our Business Partners, or to otherwise complete the transactions for which the personal information was collected by us or any Business Partner. Please note that if you exercise your right to opt-out of the sale or sharing of personal information between our Business Partners, it could impact our operational ability to provide you with some or all of the transportation services or other Services you have requested by or through us or any of our Business Partners; and
 - (ii) To assist us and our Business Partners in creating marketing profiles, gathering market or industry analysis, delivering targeted advertisements, or otherwise promoting our business or the business of our Business Partners.
- We may use analytics tools or services provided by a third party data analytics service provider (“**Data Analytics Providers**”) or we may use one of their tools, such as, but not limited to Shopify, or Google Analytics (“**Data Analytics Tools or Services**”). These Data Analytics Providers and/or Data Analytics Tools or Services may collect certain personal information in order to assist us in creating marketing profiles, gathering market or industry analysis, delivering targeted advertisements, or otherwise promoting the business of the Company.
- We may hire or work with 3rd party advertising companies or marketing companies (“**Advertising Network**”) and share with our Advertising Network the following types of personal information: (a) identifiers; (b) Internet network activity information; (c) commercial information; and/or (d) inferences drawn from the categories described above. Our Advertising Network may use this personal information to assist us in providing you or other parties with advertisements, marketing, or other information that we think may be of interest to you or to others.

HOW YOU CAN EXERCISE YOUR RIGHT TO OPT-OUT OF SALE OR SHARING OF PERSONAL INFORMATION

Pursuant to the Oregon OCPA, an Oregon Resident can opt-out of the sale or sharing of their personal information by submitting their request to that effect to the Company by using either of the following methods:

- By calling the Company toll free at 503-226-0700.
- By emailing the Company at info@rideconnection.org with the subject “Consumer Request.”

OTHER NOTICES

After submitting or communicating your request to opt-out of the sale or sharing of your personal information, the Company has the right to send a follow up communication to you in order to: (i) have you verify your identity; and (ii) otherwise verify the authenticity of the request and its applicability to the Oregon OCPA. It is important that you provide a valid email address in order for us to be able to verify and process your request. We cannot respond to, process, or complete your request if: (i) you do not follow the instructions provided in any such follow-up communication(s); or (ii) we cannot verify your identity or authority to make the request or confirm that the personal information relates to you.
